**Constitution
of India.**

No. MKM-2016-1087-K.H.- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Gujarat hereby makes the following rules to provide for regulating recruitment to the post of Joint Commissioner, Class I, in the General State Service under the Commissionerate of Tribal Development, Gujarat State, namely:-

1. These rules may be called the Joint Commissioner, Class I, under the Commissionerate of Tribal Development, Recruitment Rules, 2016.
2. Appointment to the post of Joint Commissioner, Class I, in the General State Service under the Commissionerate of Tribal Development, Gujarat State shall be made, either , -
 - (a) by promotion of a person on the basis of the principle of selectivity within the zone of consideration irrespective of seniority in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967 from amongst the persons, who, -
 - (i) have worked for not less than five years in the cadre of Deputy Commissioner, Class I in the General State Service under the Commissionerate of Tribal Development, Gujarat State and
 - (ii) have passed the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006 :

Provided that where the appointing authority is satisfied that a person having the experience specified in sub-clause (i) above is not available for promotion and that it is necessary in the public interest to fill up the post by promotion even of a person having experience for a lesser period; it may, for reasons to be recorded in writing, promote such person who possesses experience of a period of not less than two-thirds of the period specified in sub-clause (i) above; or

- (b) by temporary transfer on deputation basis from amongst the persons working in the cadre of Gujarat Administrative Service.
