No.MKM-2014-606-KH: In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and in supersession of all the rules made in this behalf, the Governor of Gujarat hereby makes the following rules to provide for regulating recruitment to the post of Tribal Development Officer, Class II, in the General State Service under the Commissionerate of Tribal Development, Gujarat State, namely:-

1. These rules may be called the Tribal Development Officer, Class II, in the Commissionerate of Tribal Development Recruitment Rules, 2016.
2. Appointment to the post of Tribal Development Officer, Class II, in the General State Service under the Commissionerate of Tribal Development, Gujarat State, shall be made, either,-
 - (a) by promotion of a person of proved merit and efficiency from amongst the persons, who;-
 - (i) have worked for not less than seven years in the cadre of Assistant Tribal Development Officer, Class III, in the subordinate service of the Commissionerate of Tribal Development, Gujarat State; and
 - (ii) have passed the departmental examination as may be prescribed by the Government; and
 - (iii) have passed the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006:

Provided that where the appointing authority is satisfied that a person having the experience specified in sub-clause (i) above is not available for promotion and that it is necessary in the public interest to fill up the post by promotion even of a person

having experience for a lesser period; it may, for reasons to be recorded in writing, promote such person who possesses experience of a period of not less than two-thirds of the period specified in sub-clause (i) above ; or

(b) by direct selection.

3. The appointments by direct selection and promotion shall be made in the ratio of 1 : 2.

4. To be eligible for appointment by direct selection to the post mentioned in rule 2, a candidate shall,-

(a) not be more than 30 years of age;

(b) possess,

(i) a bachelor's degree obtained from any of the Universities established or incorporated by or under the Central or State Act in India; or any other educational institution recognized as such or declared to be deemed as University under section 3 of the University Grants Commission Act, 1956; or possess an equivalent qualification recognized as such by the Government;

(ii) the basic knowledge of computer application as prescribed in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967;

(iii) adequate knowledge of Gujarati or Hindi or both;

5. The candidate appointed by direct selection shall be on probation for a period of two years.

6. The candidate appointed by direct selection shall during his probation period require to undergo pre-service training and pass the post-training examination in accordance with the provisions of the Gazetted Officer's Pre-Service Training and Examination Rules, 1970.

7. The candidate appointed by direct selection shall require to pass the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006.
8. The candidate appointed by direct selection shall require to pass the departmental examination and an examination in Gujarati or Hindi or both in accordance with the rules prescribed by the Government.
9. The candidate appointed either by direct selection or by promotion shall require to undergo such training and pass such examination as may be prescribed by the Government.
10. The candidate appointed by direct selection shall be required to furnish a security and surety bond in such form, for such amount and for such period as may be prescribed by the Government.
